1st ADDENDUM TO MEMORANDUM OF UNDERSTANDING

First addendum to the Memorandum of Understanding by and between the Federal University of São Carlos (Brazil) and University of Surrey (United Kingdom) signed on May 12th, 2017, for the promotion of academic and scientific cooperation

The Federal University of São Carlos, based on São Carlos campus, at Rodovia Washington Luís, km 235, in São Carlos, in the state of São Paulo, Brazil, herein represented by its Rector, Professor Wanda Aparecida Machado Hoffmann, Ph.D.; and the University of Surrey, incorporated by Royal Charter whose principal place of business is Stag Hill, Guildford, Surrey, GU2 7XH, United Kingdom, herein represented by its Provost and Executive Vice-President, Professor Michael Kearney; based on the Memorandum of Understanding by and between them signed on May 12th, 2017 (MoU), and in compliance with the provision in its Section 10, that any changes to the terms and conditions of the MoU shall only become effective by means of a written addendum mutually accepted by the signatory parties; do hereby resolve to execute this addendum, which formally broadens and improves the academic and scientific cooperation between the institutions:

SECTION 1 – PURPOSE

The Federal University of São Carlos and the University of Surrey agree to make the following amendments to the MoU:

1. Addition of Annexes 3 and 4, at the end hereof, about the research project Assistive Media for Health and Wellbeing in Ageing – UK and Brazil Network, which the institutions intend to jointly develop;
2. Insertion of the SECTION 3-A – ACADEMIC FEES, with the following writing: “Professors and researchers from any of the parties in mobility at the other party for up to twelve (12) months under this agreement, and for the purpose of working in projects funded by São Paulo Research Foundation (FAPESP), shall pay the academic fees (including bench fees), if any, to their home institution.”;
3. Substitution of the writing of SECTION 11 – COORDINATION with the following: “As coordinators for this MoU the following are appointed: on behalf of the Federal University of São Carlos, Ricardo Cerri, Ph.D., Professor of its Department of Computation, and Paula Costa Castro, Ph.D., Professor of its Department of Gerontology; and on behalf of the University of Surrey, Yaochu Jin, Ph.D., Professor of Computational Intelligence, and David Frohlich, Ph.D., Professor of Interaction Design.”.


SECTION 2 – CONFIRMATION


